the issue of municipal property evaluation has been a recurring concern affecting the Municipality and its ratepayers;

fluctuations and inconsistencies in the evaluation system have created financial and administrative challenges for municipalities and residents across the region;
- WHEREAS

the MRC Vallée-de-la-Gatineau has proposed a *Pilot Project on Municipal Evaluation* with the goal of improving fairness, transparency, and stability within the municipal evaluation framework;
- WHEREAS

the Council of the Municipality of Allevyn and Cawood recognizes the importance of modernizing and reviewing the evaluation system to ensure municipalities and ratepayers are not placed in difficult or unjust situations;
- WHEREAS

the Municipality believes that changes to the current evaluation process are necessary to support sustainable municipal governance and protect the financial well-being of residents;
